

## Statement of Organization SDCL 12-27-6

The Treasurer for a political committee shall file a statement of organization not later than 15 days after the date upon which the committee made contributions, received contributions, or paid expenses in excess of \$500.00. However, if such activity falls within 30 days of any statewide election, the statement of organization shall be filed within 48 hours. A candidate shall file a statement of organization for a candidate campaign committee not later

than 15 days after becoming a candidate (SDCL 12-27-3). If you are required to file with your <u>local jurisdiction</u> (county, school or municipality: candidate, ballot question committees and PACs) contact your local election official for the necessary form(s).
