If the contribution is received on or after Election Day, a supplemental statement is not required to be submitted.

Deadline to file: Within 48 hours of the time that the contribution was received if it was received within the 20 days immediately prior to an election.

File with: The Secretary of State except local political committees file with their local election official.

I also understand that failure to timely file any statement, amendment, or correction required subjects the Treasurer, who is responsible for filings under SDCL 12-27, to a civil penalty of \$200.00 (county political parties and auxiliary organizations, \$50.00) for each violation (SDCL 12-27-29.1). Additional penalties not to exceed \$250 could be assessed per SDCL 12-27-29.4. I also understand that failure to timely file reports or pay penalties could result in the candidate not being certified for office (SDCL 12-27-29.3).
