Who files this statement: State law requires that if any political committee receives a contribution of five hundred dollars or more, from any single source, within the 20 days immediately prior to an election for which a campaign finance disclosure report may be filed, a supplemental report shall be filed within forty-eight hours of receipt of the contribution (SDCL 12-27-28). If the contribution is received on or after Election Day, a supplemental statement is not required to be submitted.

Deadline to file: Within 48 hours of the time that the contribution was received if it was received within the 20 days immediately prior to an election.

File with: The Secretary of State except local political committees file with their local election official.

Forms are available on the Secretary of State's website at sdsos.gov.

No person may execute this report for any purpose other than to make a disclosure of a contribution that is subject to a civil and/or criminal penalty. A person who willfully and intentionally falsifies, conceals, or obscures a written instrument of any kind of passes and fails to file a report in a timely manner, shall be subject to a fine of \$500.00 (SDCL 12-39-36). I also understand that failure to timely file the statement of contribution and disclosure of contributions to the Secretary of State is responsible for filings under SDCL 12-27-29.1, which is a criminal offense for failure to file political parties and committee contribution info, \$50,000 for each violation (SDCL 12-27-29.1). Additional penalties not to exceed \$10,000 could be imposed under SDCL 12-27-29.4. I also understand that failure to timely file reports or pay civil fines, which become due in the quarter following the contribution, may be subject to SDCL 12-27-29.3.
