REPORT OF THE COMMISSION ON CAMPAIGN FINANCE DISCLOSURE FOR THE YEAR ENDING 1974

1. INTRODUCTION

The Commission on Campaign Finance Disclosure was established by the California State Legislature in 1972. Its purpose is to study and report on the need for and the feasibility of a system of campaign finance disclosure in California.

2. BACKGROUND

The Commission has held numerous public hearings and has received many suggestions from interested parties. It has also conducted extensive research into the various methods of campaign finance disclosure used in other states.

3. FINDINGS

The Commission has found that there is a strong public interest in knowing how candidates for public office are financed. This information is essential for voters to make informed choices at the ballot box.

4. RECOMMENDATIONS

The Commission recommends that California enact a comprehensive campaign finance disclosure law. This law should require candidates for state and local offices to disclose their sources of campaign funds.
