# Campaign Finance Disclosure Report



Section 104.04, Florida Statutes, requires every candidate for elective office to file a campaign finance disclosure report with the Secretary of State. The report must be filed by the candidate or the candidate's authorized agent, and must be filed by the deadline specified in the statute. The report must contain the following information:

(a) The name of the candidate, the office for which the candidate is running, and the date of the election.

(b) The name of the candidate's authorized agent, the address of the agent, and the date of the filing of the report.

(c) The name of the candidate's campaign committee, the address of the committee, and the date of the filing of the report.

(d) The name of the candidate's campaign treasurer, the address of the treasurer, and the date of the filing of the report.

(e) The name of the candidate's campaign manager, the address of the manager, and the date of the filing of the report.

(f) The name of the candidate's campaign chair, the address of the chair, and the date of the filing of the report.

(g) The name of the candidate's campaign vice chair, the address of the vice chair, and the date of the filing of the report.

(h) The name of the candidate's campaign secretary, the address of the secretary, and the date of the filing of the report.

(i) The name of the candidate's campaign treasurer, the address of the treasurer, and the date of the filing of the report.
